

RECOMMENDATIONS:

The Scrutiny-cum-Screening Committee constituted for the purpose of the scrutiny/screening of application forms of candidates for the post of Assistant Registrar recommends following:

1. Good academic record is mentioned as essential qualifications. In absence of any proper guideline regarding "Good academic records" it is understood that Masters degree with at least 55% marks or equivalent grade with any relaxation has been considered good academic record by the committee.
2. Screening committee has gone through 150 applications including 02 late received applications, which were not considered by the committee.
3. Screening committee has made recommendation with regard to direct recruitment of candidates and candidates found eligible to be considered for deputation and same has been remarked appropriately against the candidate concerned.
